



RULES OF PROCEDURE FOR DOGS

✓ You will be asked for your pet's up-to-date vaccination record on the day of arrival. All dogs must be identified (tattooed or chipped) and vaccinated against rabies.

✓ Dogs must be kept on a lead on the campsite.

✓ 1st and 2nd category dogs are not allowed in high season. In the low season, it is compulsory to show us the dog licence and the dogs must be muzzled.

✓ The owner is entirely responsible for the good behaviour of his animal and must be able to control it in all circumstances.

✓ Any animal is under the responsibility and vigilance of its owner at all times and for any injury it may cause.

✓ In the event of an "incident" (animal defecating, vomiting, etc.), the owner will be required to collect it. Several dog waste bins have been installed for this purpose on the campsite.

✓ If the owner accepts that the animal be released from any restraint, he/she is responsible for possible accidents between animals or involving people.

✓ It is forbidden to pet other people's animals without prior permission from the owner. For children, this must be done


under the supervision of the legal representative, if authorised.

✓ Pets may be left alone in the accommodation (max. 3 hours) if the owner is present on the premises. The owner must leave a mobile phone number so that he can be contacted if the animal causes inconvenience to other guests. Think of the others, do not leave the dog alone, if you know that it will bark.

✓ Any damage caused by the pet to third parties and/or camping furniture is the responsibility of the owner. The amount of damage caused by your pet during your stay will be charged to your stay.

✓ If the animal causes inconvenience or damage to other guests, the campsite has the right to cancel the reservation without compensation.
